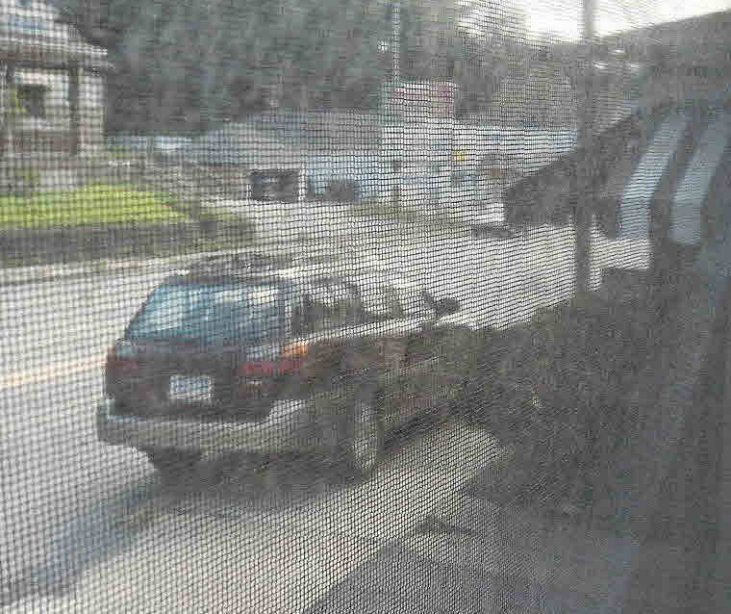

Here is an example of Ms. Kerr accusing her innocent neighbor of tampering with her mail, and the mail of Mr. Paul Morgan. Who is Paul Morgan? He is an elderly and very sick man who was living alone. Here Ms. Kerr is trying to convince her neighbor that she's been talking with with the FBI who she said referred her "complaint" to the local Post Office to be investigated. What should be understood here is Ms. Kerr has, for many years tried to convince others she is "with" the FBI!!! Furthermore, it has been proven that Ms. Kerr carried "official" shields and other forms pseudo of FBI identification that she purchased on EBAY!! She also has, for years, assumed phony online identities of FBI agents using AOL "official" sounding screen names. She interacted with dozens of people, some for long-term, in the persona of an FBI agent.
